INCOME RECEIVED

In most instances this information will come straight to our office from the ATO.

DEDUCTIONS

To claim a deduction for a work-related expense you should keep in mind the following three rules:

- 1. you must have spent the money yourself and weren't reimbursed
 - 2. the expense must be directly related to earning the income
 - 3. you must have a record to prove it

MOTOR VEHICLE EXPENSES

You can claim deductions for the cost of transport while working during one of two different claiming methods.

Travel from home to your usual place of work and vice versa does not usually constitute work travel.

CLAIM 1: Cents per km method up to 5,000kms Provide how many kms CLAIM 2: Log book method Provide logbook for work use percentage Fuel Registration & insurance Services & tyres Motor vehicle purchase invoice Motor vehicle loan contract

TAXABLE INCOME	TAX PAYABLE	
0 – \$18,200	Nil	
\$18,201 – \$45,000	19c for each \$1 over \$18,200	
\$45,001 – \$120,000	\$5,092 plus 32.5c for each \$1 over \$45,000	
\$120,001 – \$180,000	\$29,467 plus 37c for each \$1 over \$120,000	
\$180,001 and over	\$51,667 plus 45c for each \$1 over \$180,000	
* The Medicare Levy of 2% generally applies in addition to these rates
